### **Remarkable Success at Guashan Court Auction Market, plus Little Clerks Training Camp for Legal Compliance Awareness**

On January 2<sup>nd</sup>, 2024, the Changhua Branch, Administrative Enforcement Agency, Ministry of Justice (hereinafter “Changhua Branch”) hosted the “Guashan Court Auction Market” for auctions of both movable and immovable properties. The event concluded with eight motor vehicles sold plus sell-off of items, totaling NT\$772,535, in addition to the five lands auctioned for a combined total of NT\$3,672,000. These transactions contributed significantly to the national treasury and helped clear outstanding debt!

The auction and sell-off for the movable properties of the Market began at 9 AM in the parking lot adjacent to the Local Tax Bureau, Changhua County. Enthusiastic participants arrived early to register and prepare for the bidding process. Among the highlights was a 2017 CMC ZINGER. In decent condition, without taxes and fees in arrears, contains spacious passenger seating and cargo areas for versatile uses, this premium vehicle

for family and commercial use as the first item of the day was sold after 38 bids for NT\$200,000. The sale created proceeds that effectively cleared off the overdue fees of the obligor, reminding the public of the importance of settling overdue taxes and fees whilst the enforcement agencies will proceed with their enforcement to protect the obligations of the country.

Simultaneously, in the Guashan Court Auction Market, Changhua Branch implemented a legal compliance education program, featuring a Little Clerk Training joined by 5<sup>th</sup> graders from Hedong Elementary School at Hemei Township, Changhua County, who served as little clerks explaining to the public the feature and price of the items for sell-off. The little clerks achieved great results in assisting Changhua Branch in the sell-off. In addition, adhering to “justice and care”- the administration motto of the Administrative Enforcement Agency, Changhua Branch has invited the Huashan Foundation to set up a booth selling cookies, drinks, and handmade items for charity, with the little clerks from Hedong Elementary School walking about the venue encouraging the donation of uniform invoices.

The little clerk training also included a mock auction where two student groups acted as auctioneers auctioning items including a dinosaur pencil case and a thermos cup set, for bidding by pupils using 8 chocolate coins given to them respectively as bidding tokens. The pupils, going from feeling strange and shy to lively engagement, raised funds and offers as the bidding went intense. The dinosaur pencil case, the first item of the day, was sold for 26 coins after 14 bids; the thermos cup

set, the second item of the day was sold in the more fervent auction for 60 coins after 30 bids. The entire auction was filled with fun and laughter. With the little clerk training and charity sales in the Guashan Court Auction Market, Changhua Branch offers mock auction experiences for pupils to gain awareness of legal compliance, justice and care at early stages.

Held quarterly, the “Guashan Court Auction Market” has become a hallmark of the Changhua Branch. Future events will continue to offer a diverse and high-quality selection of goods to attract more attendees. Additionally, the Branch will organize the “123 Joint Auction”- concentrated auctions of movable properties first Tuesday each month, open for bidding on site and correspondence. Furthermore, Changhua Branch will host its movable property sell-off at its Nantou Office (No. 1-30, Zhongzheng Rd., Nantou City) on March 5.
