Immediate Payment Secured After Seizure Threat for License-less Driving and Refusal of Breathalyzer Test

In Xihu Township, Changhua County, Zhou, a male in his thirties, faced swift legal consequences after being caught riding a motorcycle after the license revocation and refusing a breathalyzer test. After the incident, Changhua Station of Taichung Motor Vehicles Office, Highway Bureau, MOTC (hereinafter “Changhua Station”), imposed fines totaling NT\$189,000. Despite receiving the penalty notices, Zhou failed to make any payments, prompting the case's transfer to the Changhua Branch, Administrative Enforcement Agency for compulsory enforcement.

Initially, the Changhua Branch attempted to resolve the matter by contacting Zhou via telephone, in which Zhou promised to settle the fines. However, the payment has been delayed. With no other significant assets registered to his name except his residence, the Branch decided to register a seizure on the property to prevent further evasion. As the property

boundaries were being officially designated, Zhou's family contacted the enforcement office proposing to settle the fine in three installments. Nevertheless, upon the enforcement officer's arrival at Zhou's residence for demarcation, the family immediately presented a postal order for the full amount of NT\$189,100, including necessary execution costs, thereby settling the fines in full. They explained that Zhou was not currently employed and not at home, requesting that the enforcement process not disturb Zhou's elderly grandfather who was resting inside. The enforcement officer did not proceed with posting a seizure notice on the property, and following the full payment, immediately processed the cancellation of the property's seizure registration.

The Changhua Branch urges the public to adhere to traffic laws and avoid unlicensed and drunk driving, which pose severe risks to themselves and others. The Branch stresses that it will continue to enforce these cases rigorously and swiftly, advising individuals to comply promptly with fines and not rely on luck, ensuring safer roads for everyone.
