Changhua Branch Promotes Legal Awareness at National Changhua University of Education Interactive Skit Receives Enthusiastic Response

To deepen students' understanding of the rule of law and integrity, Director-General Ching-Ming Kuo of the Changhua Branch of the Administrative Enforcement Agency, Ministry of Justice (referred to as the Changhua Branch) led the staff to National Changhua University of Education on May 24, 2024, for the second edition of this year's "Hand in Hand with Youths for Integrity" legal education campaign. In addition to an introduction to administrative enforcement by officers, owing to the popularity of the skit "on-site enforcement on drunk driving obligors" from the previous edition, its prequel was presented in this event as an extra, during which the Branch staff depict the pre-enforcement process and property seizure in a lighthearted and whimsical manner. The interactive performance was well-received by the students.

The event began with administrative officers introducing the scope of their work and innovative practices at the Changhua Branch, such as the "Guashan Court Auction Bazaar", "Convenient Multi-payment Measures", and the "County Highway 139 Project", providing students with insights into the practical operations and unique features of the Branch. The event proceeded with the Branch staff's performance of a lively skit demonstrating the enforcement procedures for a drunk driving obligor who refused to pay fines, from property seizure to voluntary payment, leaving a strong impression on the students. The humorous and engaging skit included interactive segments where students responded with quick wit, creating a lively atmosphere filled with laughter. To further engage students, a quiz with prizes was held in the latter half of the event, during which students answering correct answers may win dainty promotional merchandise from the Branch. The students showed proactiveness as they attempted to become the first answering the questions. Many expressed through feedback forms that the skit was both entertaining and informative, offering them a deeper understanding of the agency's work.

According to Director-General Kuo, to strengthen students' legal awareness and enhance cooperation with universities, the Changhua Branch is willing to offer internship opportunities to students from National Changhua University of Education, through which students can explore diverse career options by experiencing the operations of administrative enforcement. The Changhua Branch expects that through this campaign, the values

of integrity and adherence to the law will be instilled in students, who may, in the future, become teachers and pass these values on to their students, thereby fostering a culture of "honesty and lawfulness".
