Changhua Branch Collaborates with Taiwanese Professional

Baseball League CPBL to Promote Legal Awareness at

Dongshan Elementary School

To help students understand the core values "enforcement with love and charity unhindered" and functions of administrative enforcement agencies, as well as how to prevent fraud and take precautions, Director-General Ching-Ming Kuo of the Changhua Branch of the Administrative Enforcement Agency, Ministry of Justice (hereinafter the "Changhua Branch") led the staff to Dongshan Elementary School in Yuanlin City, Changhua County (hereinafter the "Dongshan Elementary School", on June 27, 2024, for awareness campaign in the Branch's legal education and anti-fraud campus tour. This event marked the first collaboration with the Chinese Professional Baseball League (hereinafter the "CPBL"), which donated practice balls to the Elementary School's baseball team, contributing to the promotion of student baseball engagement within the jurisdiction of the Changhua Branch.

Before the event began, Principal Jian-Kai Wang of Dongshan Elementary emphasized the importance of understanding legal concepts to the students and announced the CPBL's donation of practice balls used by professional baseball players, during which the students eagerly awaited the arrival of the Changhua Branch representatives, their excitement clearly visible on their faces. Director-General Kuo warmly responded to the students' enthusiasm, explaining that the purpose of the legal education tour was to familiarize them with the work of the administrative enforcement agency, and to cultivate a lawabiding mindset and fraud prevention awareness. Albeit the fact that the students may not directly engage in administrative enforcement work, their understanding may positively influence their families and communities, promoting societal well-being.

The event began with an introduction to the administrative enforcement work by the officers, helping students understand the dual approach of justice and compassion in enforcement. The Changhua Branch staff then performed a lively skit, depicting the procedures of enforcing penalties for drunk driving and seizing property, which left a strong impression on the students. The skit included interactive Q&A sessions with the students, who actively participated and absorbed the importance of law-abiding behavior and how to verify potential fraud.

The highlight of the event was a mock auction where young baseball players participated in bidding for autographed baseballs by professional baseball stars including Chien-Ming Wang and Giljegiljaw Kungkuan, which are the courtesy of CPBL. During the mock auction, the auctioneer professionally introduced the baseball stars to increase the value and excitement of the items. The young players, already familiar with their idols' plays, eagerly bid on the autographed balls, pooling their resources and competing fiercely. This engaging and educational activity provided the students with an unforgettable experience. The event concluded with Director-General Kuo presenting practice balls and autographed balls to Dongshan Elementary on behalf of the CPBL. This wellorganized event has earned unanimous praise from the principal, teachers, and students.

The Changhua Branch stated that to effectively instill lawabiding principles in students from an early age, they are breaking away from traditional, rigid, and didactic frameworks. By adopting innovative and lively methods, they "interpret" the role of administrative enforcement agencies, instilling law-abiding and anti-fraud awareness in students.
