Changhua Branch and CPBL Join Forces Again to Promote

Anti-Fraud and Anti-Drug Campaign at Sanguang Junior

High School

In order to help students understand the importance of preventing fraud and rejecting the dangers of drugs, as well as the core values and work of the administrative enforcement agency, Kuo Ching-Ming, Director of the Changhua Branch, Administrative Enforcement Agency, Ministry of Justice, led a group of his colleagues to the Sanguang Junior High School in Mingjian Township, Nantou County, on August 27, 2024 to educate students on the rule of law and to promote the concept of law-abidingness through lively and engaging educational content and drama. It is hoped that students will bring positive influence to their families and society, promoting the virtuous cycle within their communities.

Prior to the start of the outreach activity, Director Kuo greeted the student baseball players who continued to come to the school for

practice during the summer vacation and shared with the students the purpose of the Changhua Branch's school outreach activity. Apart from promoting the rule of law education in schools, through this joint activity with the Chinese Professional Baseball League (CPBL), the league donated practice balls to the school's baseball team for training purposes, showing its dedication to the players who love playing baseball and training diligently.

The activity began with a presentation by administrative enforcement officers about the work of administrative enforcement, which helped students understand the way administrative enforcement agencies work with both justice and care. In addition, the staff members of the Changhua Branch presented a lively and entertaining drama to show the procedures of administrative enforcement and seizure of movable assets by the enforcement officers against obligors involved in drunk driving, aiming to deepen the students' understanding of administrative enforcement practices. The drama was also interspersed with interactive questions and answers with the students, which encouraged the players from different parts of Nantou County to get rid of their shyness, raise their hands, and express their thoughts bravely. In addition to letting the students know about the work of administrative enforcement agencies, the drama also instilled an awareness of fraud prevention and the importance of staying away from drugs.

The last part of the event was for student baseball players to participate in a mock auction process. The items auctioned off were autographed balls of professional baseball stars Chen Chieh-Hsien and Peng Cheng-Min, which were enthusiastically sponsored by the CPBL. During the mock auction, the auctioneer professionally introduced the baseball stars in the hope of raising the price and increasing the participants' desire to buy, and the players kept bidding for their idols' autographed balls with selfmade tokens provided by the Changhua Branch. The students who finally purchased the auction items through the joint venture even took pictures with the autographed balls to celebrate the success of their first auction in their lives. The whole event was concluded with a ceremony in which Branch Director Kuo Ching-Ming presented Sanguang Junior High School with a practice ball and an autographed ball on behalf of the CPBL.

The Changhua Branch indicated that in order for law-abiding citizens to take root on campus, strengthen students' concepts of fraud prevention and deepen their anti-drug awareness, members of the Changhua Branch will continue to be creative and visit campuses in innovative and lively ways, giving full play to the multifaceted functions of an administrative enforcement agency.
