Grabbing Bargains Online is Easy! The First Launch of "Changluo Easy Shopping for Goodies" Achieved Good Results

In October 2024, the Changhua Branch Office of the Administrative and Executive Yuan of the Ministry of Justice (hereinafter referred to as the Changhua Branch) held its first "Changluo Easy Shopping for Goodies" online auction, which generated NT\$47,500 in sales in just three days. This was the first time that the Changhua Branch used Google Forms to sell seized items. The online auction provided 11 items with good quality and low prices, and items such as handmade soap sets and yoga mats were sold out soon after the sale began. In addition, 170 Apple phone charging cables and Type C charging cables at NT\$50 each were frantically snapped up, creating a "triple win" scenario for the obligors, the public, and the national treasury.

The jurisdiction of Changhua Branch covers Changhua County and Nantou County, where the Maoluo River meanders and flows, giving rise to unique local customs. The name "Changluo Easy Shopping for Goodies" is based on the fact that the branch office is located in Changhua, combined with the Maoluo River that flows through the area, which not only reflects the local affection, but also conveys the mission of the Changhua Branch in creating a better community together with the local residents.

Due to the impact of the economic downturn or the lack of marketing strategies, many obligors are unable to pay their taxes and other public law debts because their income has fallen short of expectations. For the purpose of expanding sales channels for those obligors who are experiencing financial difficulties, "Changluo Easy Shopping for Goodies" and the quarterly "Guashan Court Auction" each play their respective roles. The online sale provides an electronic shopping platform for people who are unable to attend the Guashan Court Auction held on weekdays, and at the same time, it also helps obligors with financial difficulties to clear up their arrears, achieving several benefits in the process.

The Changhua Branch indicated that it paid great attention to every detail in the planning of this online sale. From the design of the Google Forms to the subsequent payment and delivery processes, the Changhua Branch strives to provide the best possible shopping experience for its customers. The Changhua Branch also carries out its administrative execution duties with heartfelt care and a genuine concern for the public's plight, assisting obligors in clearing up their outstanding taxes and fees by seizing and then legally auctioning off their assets or realizing them, translating justice and care into practical actions to help the disadvantaged obligors tide over their hardships. In addition, the Changhua Branch would like to remind the public that they should not ignore the notification of the subpoena by the Branch by assuming that it is the work of a fraudulent group.
