Changhua Branch Joins Forces with District Prosecutors

Office to Combat Drugs and Frauds

The Changhua Branch, Administrative Enforcement Agency, Ministry of Justice, held a joint auction of movable and immovable assets on the morning of November 11, 2024, in response to the joint auction of cases related to the policy of "cracking down on five types of crime and upholding seven types of safety" and an anti-fraud publicity project in all branches of the Administrative Enforcement Agency, Ministry of Justice. The auction was held at No. 367-5, Sec. 2, Zhongshan Road, Huatan Township, Changhua County, which is the vehicle storage area of Changhua District Prosecutors Office. The Chief Prosecutor Chang Hsiao-Wen, and the Director Kuo Ching-Ming came to the event and cheered for all participating colleagues, demonstrating the seamless cooperation between the Changhua Branch and the Changhua District Prosecutors Office.

Before the event started, the organizer showed a short video on the policy of "cracking down on five types of crime and upholding seven types of safety", and the event also included a question-and-answer session with prizes for promoting the rule of law education. Among the many auction bids, the most notable one was a white Honda car manufactured in 2015, which was finally auctioned off for NT\$195,000 after 16 bids. The proceeds from this joint auction totaled NT\$347,840, which not only effectively contributed to the national treasury, but also helped to clean up the confiscated items in the Changhua District Prosecutors Office's loot storage.

On the day of the event, the Department of Education, Changhua County Government sent an "Anti-Drug Campaign Bus" to support the event. Through the display of drug samples and interactive games, the public was able to learn the correct knowledge of combating drugs, enabling them to become a good fighter against drugs. The Changhua District Prosecutors Office also set up a booth to educate the public on the correct concepts of combating frauds and drugs, demonstrating the government's commitment and determination in law enforcement and eradicating fraud.

The Changhua Branch is responsible for the enforcement of public law monetary payment obligations.
