**Changhua Branch Joined Forces with the District
Prosecutors Office to Host “Anti-Fraud, Anti-Gambling”
Educational Activity for Professional Basketball Players**

For the purpose of educating SBL professional basketball players about the importance of preventing fraud and the core values and work of the administrative execution agency “enforcement with love and justice without obstacles,” on December 10, 2024, Mr. Kuo Ching-ming, Director of the Changhua Branch, Administrative Enforcement Agency, Ministry of Justice, led a group of SBL professional basketball players to participate in a rule of law education activity organized by the Taiwan Changhua District Prosecutors’ Office (Changhua District Prosecutors Office). The event featured lively promotional content and dramas to help Changhua BLL basketball players understand the meaning of administrative execution as the last mile to achieve social justice, as well as to instill the concepts of legal compliance

and fraud prevention in young players, thus giving full play to the positive functions of administrative execution agencies.

Before the event began, the Changhua Branch and Changhua BLL basketball players visited the detention room and simulated the opening of the courtroom, giving the young professional basketball players a chance to experience the process of compulsory disposal in criminal litigation in order to instill correct legal concepts in them. By joining hands with the Changhua District Prosecutors Office to promote rule of law education, the Changhua Branch is doing its part to nurture a fresh environment for young professional basketball players who love the game and train with dedication.

The Changhua Branch's rule of law education for young players breaks away from the traditional mode of dull and uninteresting lectures, and presents the work of administrative execution through the on-site drama of execution obligors, allowing the players to understand the execution methods of the administrative execution agencies that are both righteous and caring, and reminding them not to ignore the notices of subpoenas from the Branch. Instead, they should use the correct identification methods to verify the case and honestly pay the tax in accordance with the law.

In his speech following the program, Changhua Branch Director Kuo Ching-ming told the participants that administrative execution is not a heartless government department. The mission of administrative execution agencies is not only to ensure the

realization of the national creditor's rights through the use of firm and flexible execution methods and fair law enforcement, but also to educate the public to abide by the law and to produce the substantive effect of "preventing violation of the law" and to fulfill the mission of ensuring compliance with the law. He hoped that the players would fulfill their social responsibilities, and the team would have a wonderful season and reward their fans with the best performance.

In the future, the Changhua Branch Office will continue to uphold the principles of justice and care, inheritance and innovation. In addition to making good use of the enforcement measures granted by law to improve the effectiveness of administrative execution, the Branch will also frequently collaborate with various social organizations to let the public understand the work and core values of administrative execution agencies, as well as to put the concept of law-abidance into practice, thus bringing the multiple functions of administrative execution agencies into full play.
